



## 2025-2026 Payment Agreement

By registering with Azuri Performance Volleyball Academy, you accept the financial obligations associated with the athletes' participation and agree to pay the total cost for the entire 2024-2025 season. The seasonal dues for each athlete includes the cost for uniforms, player packs, training, local tournament entry, facility rental, and other associated fees.

The total cost for the 2025-2026 season with Azuri Performance Volleyball Academy will be **\$600 per athlete**, payable to Azuri Performance, LLC.

There are three payment options available this season:

- Option 1: Full payment at registration for a reduced rate of \$550 per athlete  
Payment due by 11/1/2025
- Option 2: First payment of \$300 due upon registration by 11/1/2025  
Second payment of \$300 due on 2/15/2026
- Option 3: First payment of \$300 due upon registration by 11/1/2025  
Three monthly payments of \$100 due on 1/15/2026, 2/15/2026, 3/15/2026

All late payments will be subject to a late fee. On day 5 of outstanding payments, there will be a late fee of \$10 per day charged to the athlete's account. After 10 days of outstanding payments, the athlete will be subject to suspension or termination. Failure to adhere to this payment agreement may result in suspension from competitions, suspension from the program, or complete termination for the remainder of the season.

If for any reason you will not be able to fulfill your payment on time, please contact the club director in advance to discuss payment options.

### **Badger Region Volleyball Association's Policy On Unpaid Player Dues**

This is taken directly from the Badger Region Volleyball Association's Club Director Handbook:

*A Junior Club player must remit all club fees as specified by their Club/Team, within the club's scheduled time frame. If fees are unpaid at the end of the Club's season, the Club Director may use any legal means necessary to obtain payment, i.e. collection agency or small claims court. Nonpayment or outstanding items owed may also result in the club submitting the athlete's name to the Badger Region office for placement on the Delinquent List, which is available to any club director who is looking to make offers for their club or add players to a team. A notice will also be placed in the player's membership record for informational purposes. Club directors should also inform families that by not fulfilling their responsibilities, their child may have received improper benefits, which is a WIAA violation and could put their child and their child's team in jeopardy for WIAA (or their state's) high school eligibility. Club directors may also choose to notify the high school coach of this, and the Region will make available names to high school coaches who are seeking information. A letter or email requesting payment should be sent to the family prior to submitting the athlete's name for the Delinquent List, and it should include the parent's name, player's name, player's age level and notification of this policy, with a copy to the Region office. Club directors must notify the Region office immediately when payment has been made. All contracts and payment circumstances are between the club and the family, the Region does not get involved in financial disputes.*

### **Refund Policy**

1. When you register to participate with Azuri Performance Volleyball Academy, you accept the financial obligations for the entire season. Payments go directly toward uniforms, facility dues, local tournament entry, and other fees.
2. Paid dues are non-refundable for any reason, even in the event the athlete quits, is suspended, or is terminated at any point in the season.
3. Refunds will not be given to athletes who choose to not play due to conflicts, team or coaching assignments, or an individuals' amount of playing time.
4. Consideration will be given only in instances where there is a remaining balance on the athlete's account AND the athlete has suffered a season-ending injury during practice or competition while playing for an Azuri Performance team. This will be on a case-by-case basis with a signed letter from a physician.
5. All requests will be reviewed, and final decisions made by the club director.
